# CONSIDERATION OF WEST GLEN 2 SUBDIVISION WATERLINES

JMK Partners, LLC completed water distribution system for West Glen Subdivision 2<sup>nd</sup> plat. The project was inspected as it was built to our approved specifications. The system has been in opertion for more than a year with no issues. The total cost of the project, including engineering and administrative costs, was \$162,304.00.

# CONSIDERATION OF CONTRACT WITH BENESCH FOR WATERLINE REPLACEMENT SPRUCE AND GRAND

The main along Spruce is under pavement resulting in expensive repairs. The current watermains recommended for replacement are a mix of 2", 6" and 8" diameter cast iron with a history of breaks. The new watermains will be 8 inch diameter and will provide additional fire protection. Alfred Benesch quoted a design fee not to exceed \$114,500.

Upon motion from Director Peterson, seconded by Director Lough, motion passed 3-0.

**RESOLVED (No. 15270),** that the Board authorized the General Manager to execute the design contract for Waterline Replacements Spruce Street from Terrace Road to S 10<sup>th</sup> St with Benesch at a not to exceed cost of \$114,500.
